### Dust Collection Systems for 6,500 cfm to 1,500 cfm




**Large systems**, up to 6,500 cfm, are used for primary sources of dust such as large Jaw and VSI crushing stations, as well as larger Vibrating Screens.



**Intermediate systems**, 2,500 to 4,500 cfm are used on Cones, Screens, Hoppers and mid-sized Transfer Points.




**The smallest systems**, 1,500 to 2,500 cfm, capture dust at strategic points such as Discharge Conveyors. All systems meet Air District requirements.





### Our Bag System Offers Better Filtration and Stays Cleaner Longer Than Others



The Dalamatric® system uses an envelope-shaped filter bag and pulses of air to provide greater movement of the bag to dislodge more challenging dust cakes during filter pulsing. The dislodged dust cake falls into the collection hopper for final removal or is routed directly back into the process.
